# Susquehanna Area Regional Airport Authority Airport Operations Committee April 19, 2024 Minutes

A meeting of the SARAA Airport Operations Committee was called to order by Mr. Leonard at 8:33 a.m. on Friday, April 19, 2024, with the following members of the Committee present:

## Public Comments: None.

<u>Minutes:</u> The minutes of the March 22, 2024, Airport Operations Committee were deemed approved with no changes.

#### Marketing & Enplanement Report:

Mr. Miller reported that March 2024 MDT Operations were down 6% vs March 2023. 1Q24 MDT Operations were down 2% vs 1Q23. Passenger and Cargo operations are down 5% YTD. March 2024 CXY Operations were up 6% vs March 2023. 1Q24 Operations are flat vs 1Q23. Local GA operations are up 5% YTD. March 2024 Air Cargo Tonnage decreased 12% vs March 2023. 1Q24 cargo is down 1% vs 1Q23. March 2024 Enplanements were 57,364, up 7.7% vs March 2023. 1Q24 was up 6.7% vs 1Q23 and up 1.5% vs budget. 1Q24 enplanements were up 1.5% vs budget. 1Q24 Load Factor was 88.4%, up 1.1 points vs budget. 1Q24 capacity was up 0.3% vs budget. 2Q24 enplanements are forecast to be up 11% vs budget on an equal increase in capacity. CY 2024 currently pacing for 685,000 enplanements, 3% above budget of 668,000. American, Delta and Allegiant are increasing seats and generating opportunities for passenger growth. March 2024 traffic is now at the 2<sup>nd</sup> highest level since September 2012, the 5<sup>th</sup> highest point over the past two decades, 85% of 2019's record.

Marketing Update: Mr. Edwards and Mr. Miller will be attending the Jumpstart Conference on May 20 to May 22 in Washington, DC. Meetings will be held with American, Delta, Unted, JetBlue, Southwest, Viva Aerobus, and Landline Bus Company

## **Project Update:**

Mr. Pirozzi reported on the following:

Status of Major Projects:

HIA:

Cargo Apron Expansion, Phase 5: Continue demolishing existing structures and utilities. Continue submittals and material procurement.

Reconfigure Third Street: Contractor will reseed areas that did not achieve minimum growth. The final inspection will be held after growth is established.

<u>Upgrade Water Plant, Phase 1, HIA</u>: Site restoration work will be completed the week of April 29<sup>th</sup>. Substantial completion inspection for Lobar was held February 27, 2024.

Replace Passenger Boarding Bridges: Project was rebid on March 24, 2024. Bids will be opened on April 25<sup>th</sup>.

Rehab Water Tower #4: NTP was issued on March 6<sup>th</sup>, 2024. Blasting/primer coat application work began on April 18, 2024. Work will be completed in June 2024.

#### CXY:

Remove Obstructions – Off Airport Tree Removal Phase V: Project will be bid for construction starting 5/12/2024 with a bid opening of 7/1/2024. The grant application is due 7/12/2024.

#### **GRA**:

Construct South Aircraft Parking Apron: Project will be bid for construction starting 3/24/2024 with a 4/26/2024 opening. The grant application is anticipated to be received September 2024.

#### FCRA:

<u>Update Master Plan</u>: Currently addressing FAA's comments for Working Paper No. 2. Finalize draft ALP and submit for FAA review.

# Award Construction Contract to Replace Airfield Lighting, HIA:

Mr. Edwards reported that this is to authorize the Executive Director to execute a construction contract with Bruce-Merrilees Electric Company in the amount of \$579,964 to replace BRITE unit airfield lighting controls at HIA. This project will replace HIA's existing BRITE unit airfield lighting controls with updated AGLAS technology. One bid was received from Bruce-Merrilees Electric Company and it was deemed to be responsible, responsive and a fair market value. This project was identified as a priority in SARAA's 2024 budget and will be funded from the capital project account.

There were no objections to forwarding this item to the full Board for approval.

#### **Dunkin Donuts Lease Assignment:**

Mr. Edwards reported that this is to authorize the Executive Director to execute a lease assignment to Siyade LLC. Dunkin Donuts has successfully been in operation at HIA since 2014. KPV Harrisburg Airport LLC approached SARAA with a request to assign their Dunkin Donuts concession lease agreement to Siyade LLC. Siyade LLC is owned by Atreia Sindiri who operates the Auntie Anne's franchise at HIA. This assignment will not relieve the KPV of any of its obligations under the lease. KPV will be supporting Siyade LLC with their operations and guiding them in the upcoming full store remodel process that will be completed by the end of the year.

There were no objections to forwarding this item to the full Board for approval.
